# - To Strengthen National Sport Federation Governance - (Summary)

#### ◆ Summary and Purpose

- Voluntary Governance guidelines for the National Sport Federations (NSF) in Japan
- The purpose for establishing these guidelines is to strengthen a fundamental framework of organizational management, which include:
  - 1. Development and Promotion of Sport, and Athlete Performance Improvement
  - 2. Implementation of the Principles of the Basic Act on Sport and "Athlete First"
  - 3. Autonomous and Self-Sustainability
- Guidelines named "Fair Play Guideline for the administration of National Sports Federation(NSF)"
- These guidelines were established in 2014, based on surveys and studies by the "Expert Committee on Governance for Sport Entity" held by the Japan Sports Arbitration Agency (JSAA), which was delegated by the Ministry of Education, Culture, Sports, Science and Technology (MEXT), JAPAN.

◆ List of the "Good Governance Guidelines for NSF"

### 1. Guidelines throughout Management

(i) Master Plan (3 elements)
$\square$ a. The master plan (including both long term and short term) for the NSF
administration of each business area, including development and promotion of
Sport, athlete performance improvement and marketing strategy, etc., should be clearly established.
☐ b. The implementation, evaluation and improvement of the master plan for the NSF
administration should be based on "Plan-Do-Check-Act (PDCA) cycle".
☐ c. The master plan for the NSF administration and the implementation status should
be made public on each NSF's website and elsewhere.
(ii) Compliance (1 element)
□ a. The regulations and systems for the NSF, its officers and employees and other
members to comply with applicable laws should be established.
(iii) Human Resources (1 element)
$\square$ a. The development and the recruitment of new human resources of the NSF should
be systematically implemented.
(iv) Diversification of Funding (1 element)
□ a. The efforts to secure diverse funding should be made to ensure the strength of NSF finances

# 2. Guidelines for Management System

(i) Distribution of the Management Authority (1 element)
a. The distribution of the management authority (congress, board of directors, various committees, etc.) should be clearly specified in the NSF constitution or bylaws, and implemented in accordance with said regulations.
 (ii) Proper Composition of the Congress and the Board (4 elements)
a. The member of the management authority should be selected to ensure that a broad range of the NSF stakeholder opinions are reflected (diversity).
b. The member of the management authority should be included outside experts (company board members, lawyers, accountants, persons with academic experience, etc.) from the NSF.
c. The regulations and procedures for selecting members of the management authority should be clear and transparent, and the selection should be implemented in accordance with said regulations and procedures.
d. The regulations of term limits for the member of the management authority should be established, and term limits should be implemented in accordance with said regulations.
(iii) Proper Procedures for the Congress and the Board (4 elements)
a. The procedures of the management authority (congress, board of directors, various committees, etc.) should be stipulated in the NSF regulations (constitution, bylaws, etc.), and the procedures should be implemented in accordance with said regulations.

## 3. Guidelines for Business Operation

(i) Clarification of the Operating Authority and Responsibilities (1 element)
a. The operating authority and responsibilities of departments or persons in charge in the NSF secretariat and approval procedures should be stipulated clearly in the NSF regulations.
(ii) Enforcement of the Operation Rules (4 elements)
a. The regulations for the NSF business operation should be established, and the business operation should be implemented in accordance with said regulations.
b. The regulations ensuring the transparency of economic interests of the director, secretary general, etc. of NSF should be established, and the provision of economic interests should be implemented in accordance with said regulations.
c. The regulations of bidding procedures for the NSF major contracts to prevent illegal profit sharing should be established, and these procedures should be implemented in accordance with said regulations.
d. The NSF business operation should be proactively supported with experts in law, taxes, accounting and other areas.
(iii) Audit of the Business Operation (2 elements)
a. The accounting and operational audits of NSF should be conducted by auditors, and audit reports should be prepared pursuant to the applicable law.
b. The measures to ensure the effectiveness of audits (internal audits by experts, the independence of auditors, etc.) should be implemented.

# **5. Guidelines for Discipline and Dispute Resolution**

b.	The member of the NSF discipline and dispute resolution body should be
	independent and neutral from the NSF management authority, and be specialized in law.

	parties concerned due process and acceleration of proceeding.
d.	The establishment and implementation of the NSF discipline and dispute
	resolution procedures should be supported by legal experts.
e.	The automatic arbitration clause for all discipline and disputes in NSF to use the
	Japan Sports Arbitration Agency (JSAA) on first instance procedures or appeal
	procedures should be established and implemented.
f.	The regulations of the NSF discipline and dispute resolution procedures should
	be made public on the NSF website and elsewhere.

### 6. Guidelines for Disclosure

a.	The organizational chart, lists, names and backgrounds of directors and managers, etc. should be made public on the NSF website and elsewhere to understand the NSF management authority.
